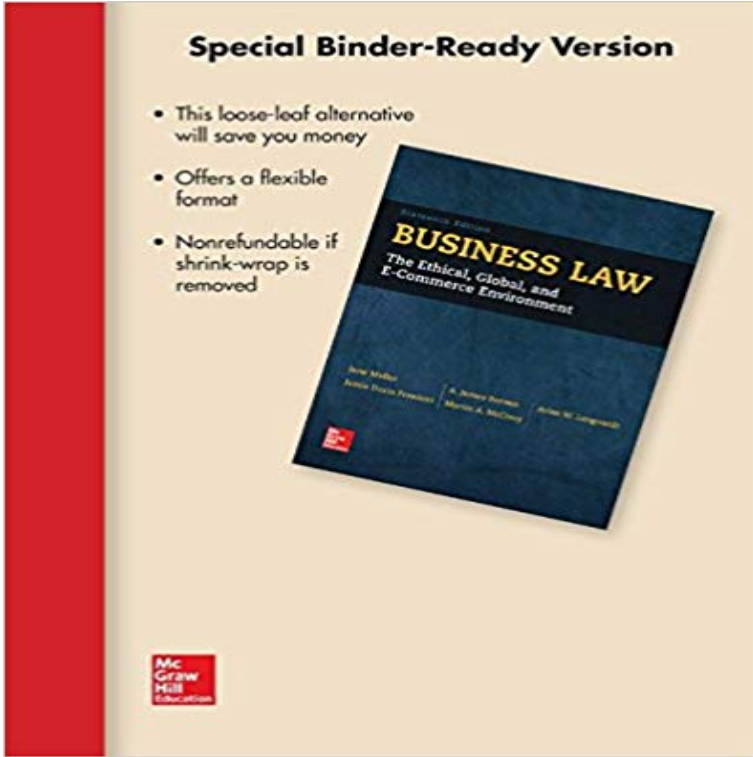


Loose-Leaf for Business Law
