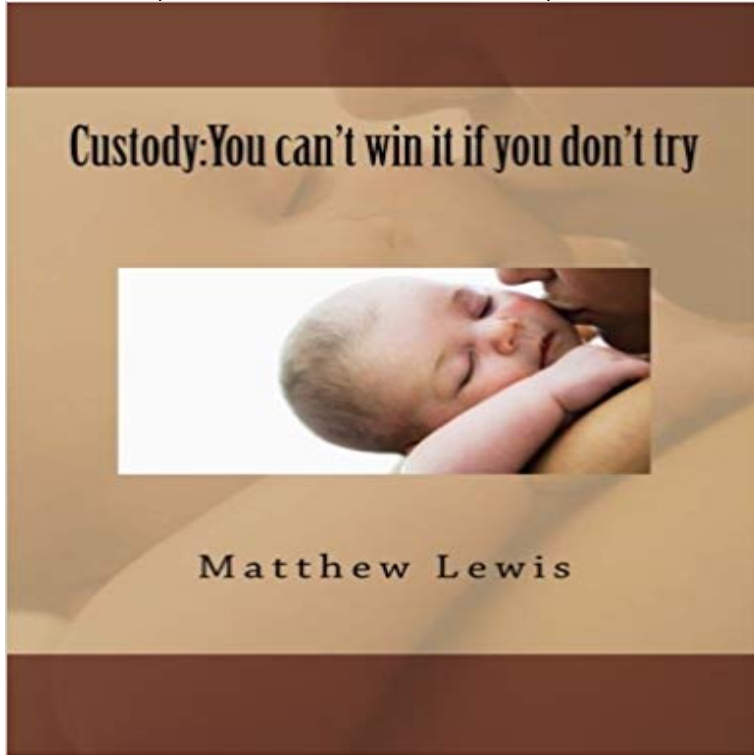


Custody: You can't win it if you don't try
