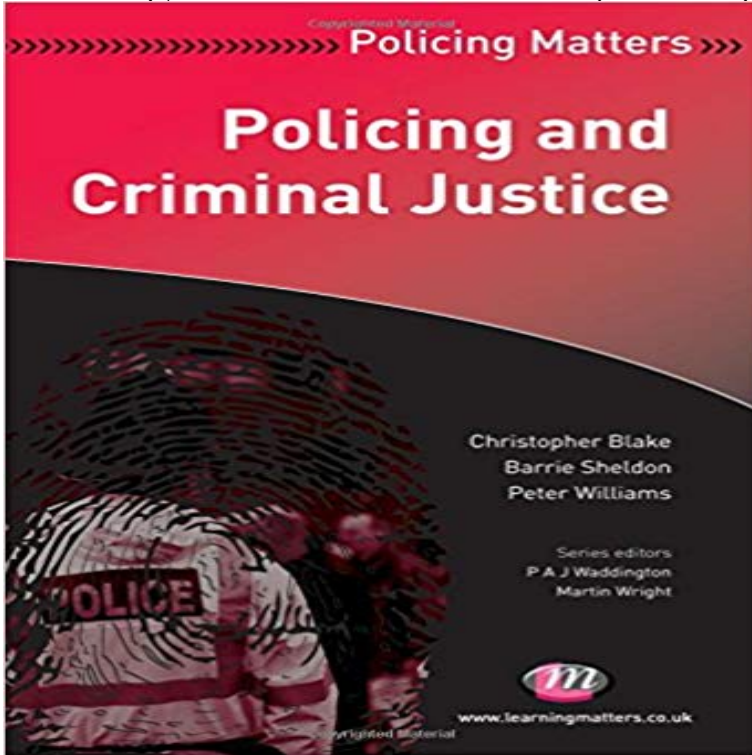


Policing and Criminal Justice (Policing Matters Series)
