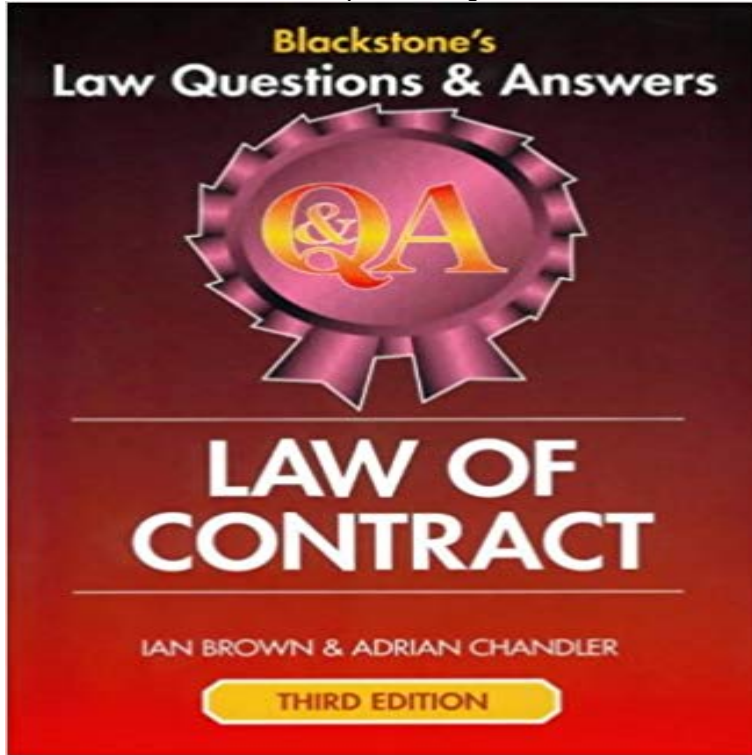


# Law of Contract (Law Questions & Answers)

Moreover, problem questions have been updated to take account of seminal decisions in areas such as fraudulent misrepresentation and undue influence as in *Smith and New Court Securities Ltd v Scrimgeour Vickers Ltd* (199) and *Royal Bank of Scotland v Etridge (NO. 2)* (1998).
